Adopted Ordinances at the March Board Meeting

Ordinance No. 749 was passed and approved on March 13, 2024 by the Village of Clarks Board of Trustees. AN ORDINANCE OF THE VILLAGE OF CLARKS, NEBRASKA TO AMEND ARTICLE 4 OF CHAPTER 10 OF THE CODE OF THE CLARKS MUNICIPAL CODE TO CREATE AN OCCUPATION TAX FOR CASH DEVICES; TO PROVIDE THAT THIS ORDINANCE SHALL BE MADE A PART OF THE CODE OF THE VILLAGE OF CLARKS, NEBRASKA; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING FOR THE EFFECTIVE DATE AND PUBLICATION THEREOF in pamphlet form.

Ordinance No. 750 was passed and approved on March 13, 2024 by the Village of Clarks Board of Trustees. AN ORDINANCE TO REVISE ALL THE GENERAL ORDINANCES OF THE VILLAGE OF CLARKS, MERRICK COUNTY, NEBRASKA; TO REPEAL PRIOR ORDINANCES AND PARTS OF ORDINANCES IN CONFLICY HEREWITH; TO REQUIRE FILING; AND TO PROVIDE AN EFFECTIVE DATE AND PUBLICATION THEREOF in pamphlet form.

Ordinance No. 751 was passed and approved on March 13, 2024 by the Village of Clarks Board of Trustees. AN ORDINANCE TO REPEAL AND REPLACE CHAPTER 90 OF THE CODE OF ORDINANCES OF THE VILLAGE OF CLARKS, NEBRASKA; TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE; AND TO DECLARE AN EFFECTIVE DATE AND PUBLICATION THEREOF in pamphlet form.
