Pet Licenses & Vaccination Records

Did you know if you live in Village limits, any animal over the age of 6 months needs to be licensed annually with the Village Office by January 1st and a copy of the current vaccinations needs to be on file.

Recently, a citizen was bitten by a couple dogs in the community. What does this mean for you as the pet's owner? If you do not have proper vaccinations for your pet, you could be liable for their medical bill to receive Rabies shots if the bite breaks their skin.

This current situation now makes those animals be considered "Dangerous". A "dangerous dog," as defined by the Code, is "[a]ny animal which attacks, snaps at, bites or has a history of attacking a human being or other domestic animal one or more times, without provocation."

A dangerous animal then must be confined to your own property by a leash or confined in a fence they can not get out of. You would need to post warning signs on your property notifying people of the dangerous animal. The next time that something would happen and someone or another animal would be bit, the animal would need to be removed from the Village.

If you have not licensed your pets with the Village Office, please do so today. Please work with us to keep everyone safe in the community.

Annual Fee for Licensing

Spayed or Neutered	\$6.25 per animal
Unaltered animal	\$11.25 per animal
