

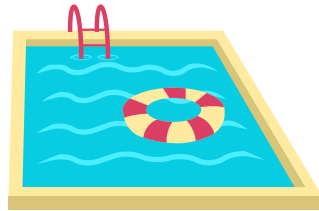

## Community Development Agency Housing Project

Building a house has so many items to arrange. The CDA trustees started by negotiating on properties. The house plans were drawn up and approved. The bids from contractors have been submitted and approved. Now the work starts to build the new home.

Once the first house is started, the board will formulate a plan for the second house.

The pledges collected in 2023 from generous donors was matched by Rural Workforce Housing grant funds. The requirements for the grant is the homes have to be built within 2 years and be under

\$325,000. The first house is being built at 308 E Amity. This lot has set empty for 20+ years. Now there will be a 3 bedroom, 2 bath house filling that vacancy.

The goal of the Community Development Agency is to sell these houses and reinvest the money back into the community, whether that be more houses or helping businesses get established.

## Municipal Code Book Changes

At the March 13, 2024 Board Meeting, the Board Trustees passed an Ordinance putting into effect an updated Municipal Code Book. A copy of the Code book can be looked at, at the Public Library or the Village Office.

### Some key items that changed are:

- 1.No person shall set any type of poisonous substance or bait within the Village limits that is deemed harmful to any pet animal or livestock; where such animal may access the poisonous substance.
- 2.It shall be unlawful for any person to own, keep or harbor any dog or cat within the Village limits unless such animal has been licensed by the Village. Pet licenses are due each year by January 1st. The fee doubles in the month of January. In the event an owner fails to voluntarily acquire a license by January 31st, he or she shall pay a charge of \$50 per animal in addition to the license fee.
- 3.***There is no limitation on breed of dogs anymore.*** If a dog is determined to be a dangerous or potentially dangerous animal, the owner shall acquire a dangerous or potentially dangerous animal license for such animal within 30 days of such determination.
- 4.It is unlawful for any person to bring any animal into the Village that has been determined to be dangerous, potentially dangerous, vicious, a nuisance or a threat to the safety of others.
